

“ORIGIN CHRISTMAS WISHES” PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents aged 18 years or over who are existing Origin Energy customers/account holders.
3. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
4. Promotion commences on 04/12/2017 and final entries close at 11:59pm AEDST on 21/12/2017 (“Promotional Period”).
5. To enter, individuals must undertake the following steps during the Promotional Period:
 - Visit <http://www.originenergy.com.au/christmaswishes> (“Website”);
 - Input the requested details including their full name, mobile phone number, email address and their State/Territory of residence. Then, when prompted answer the promotional question “**What is your Christmas wish?**” in 25 words or less. Individuals can upload supporting photographs and/or videos however this is not compulsory;
 - Check the box agreeing to these Terms and Conditions and the Promoter’s Privacy Policy; and
 - Submit the fully completed online entry form.
6. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
7. Incomplete or indecipherable entries will be deemed invalid.
8. Only one (1) entry is permitted per person.

9. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
10. The Promotional Period will be divided into twelve (12) entry periods (each an “Entry Period”). Entries open and close for each Entry Period on the dates and times outlined in the table below. The judging for each Entry Period will take place at Origin Energy Services, 321 Exhibition Street, Melbourne VIC 3000 commencing on the dates outlined in the table below. Non-winning entries in each Entry Period will be entered into any subsequent Entry Periods. The judges may select additional reserve entries which they determine to be the next best, and record them in order, in case of an invalid entry or ineligible entrant. The winners will be notified by telephone and/or email. This is a game of skill and chance plays no part in determining the winners. Each entry will be individually judged based on creativity, uniqueness and relevance to Christmas of the answer to the promotional question. 13. If for any reason a winner does not redeem a prize by the time stipulated by the Promoter, then the prize (or that element of the prize) will be forfeited.

- (e) they consent to any use of the Content which may otherwise infringe the Content creator's/creators' moral rights pursuant to the *Copyright Act 1968* (Cth) and warrant that they have the full authority to grant these rights; and
- (f) they will comply with all applicable laws and regulations, including without limitation, those governing copyright, content, defamation, privacy, publicity and the access or use of others' computer or communication systems.

Without limiting any other terms herein, the entrant agrees to indemnify the Promoter for any breach of the above terms.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of the prize.
